

Purpose: This document reconciles the corporate/legal records currently supplied for the CodeX project so that the same entity wording can be used consistently across the whitepaper, Proof-of-Reserve record, management reserve report, technical review, website and Etherscan support materials.

1. Corporate Presence Summary

Legal-form and chronology distinction: The supplied Pakistan FBR documents identify MUNNAZA USMAN as Person: Individual and list Coded House as a business/branch dating from July 2024. They do not establish a separately incorporated Pakistani company. The Wyoming LLC is a later legal entity formed in August 2026. Public documents should preserve this chronology and should not describe the Pakistan business as an LLC/Pvt Ltd unless separate incorporation evidence is later supplied.

3. Pakistan Business Presence

Corporate history: Coded House in Pakistan predates the Wyoming LLC. FBR records list Coded House as a business/branch under MUNNAZA USMAN with a business acquisition record dated 1 July 2024. The taxpayer registration record is dated 9 July 2024. Coded House LLC is the later U.S. entity; the formation-service portal record shows 24 August 2026; the Wyoming Secretary of State certificate states that the entity complied with applicable office

requirements on 25 August 2026; and Certificate ID 106838024 was issued on 27 August 2026 at 5:45 AM. These records do not by themselves establish a parent/subsidiary, asset-transfer, or legal-succession relationship.

4. Required Wording Across CodeX Documents

- Current U.S. legal entity / publisher for the September 2026 document set: Coded House LLC, Wyoming, United States - Entity ID 2026-002065283. This is the later U.S. entity, not the earliest Coded House business record.
- Earlier/original Coded House business presence: Pakistan FBR Registration No. 3740577028434 under taxpayer/owner MUNNAZA USMAN. The FBR profile shows a Coded House business acquisition record dated 1 July 2024; taxpayer registration is dated 9 July 2024; Income Tax / ATL status is Active in the supplied records.
- Do not describe the Pakistan business as a separate LLC, Pvt Ltd, or incorporated company unless separate incorporation evidence is supplied.
- Do not merge the Wyoming Entity ID with the Pakistan FBR Registration No.; they are different registrations from different jurisdictions.
- Do not use the owner's date of birth, personal phone number or personal email in public CodeX documents unless legally necessary.
